The SFWMD has contracted the Anthony James Catanese Center for Urban and Environmental Solutions at Florida Atlantic University (Center), formerly known as the FAU/FIU Joint Center for Environmental and Urban Problems, to develop the Biscayne Bay Web Site *DiscoverBiscayneBay.org*. The objective of the web site is to facilitate communication and information-sharing among Biscayne Bay decision-makers, agencies, organizations and partners (primary target audience). In the future, a secondary audience will be the general public interested in Biscayne Bay.

The web site will serve as a central clearinghouse to collect information on Biscayne Bay protection, restoration and enhancement issues and efforts, and disseminate it efficiently to the target audience. Specifically, the web site will continuously provide the target audience with updated information regarding recommendations and actions of Biscayne Bay related interest groups, programs and projects, and actions and successes related to the implementation of the Biscayne Bay Preservation Initiative.

The Miami River Commission (MRC) will have a prominent location on the web site to highlight Miami River projects and efforts and provide a link to the MRC web site.

Project: Biscayne Bay Environmental Education

The SFWMD has contracted Citizens for a Better South Florida (Citizens) to develop and implement a new coordinated comprehensive Biscayne Bay environmental education program(s) for all segments of the Miami-Dade County community: 1) primary, secondary and post secondary students and educators; 2) the general public, with an emphasis on minority groups; 3) public officials; 4) direct users of the Bay with an emphasis on boaters; and 5) tourists.

The goal of the program is to establish an informed public that will utilize and manage Biscayne Bay carefully and realize the benefits for its long-term protection and restoration.

Because the goal has not yet been realized, it is necessary to determine the situation of current education efforts and what is needed to achieve the goal. A more efficient and effective way of educating the Miami-Dade community as a whole must be established, and educators need to be more creative through coordinating efforts and resources.

This education program will initiate a new, innovative, comprehensive, and coordinated Biscayne Bay environmental education action plan, which has the potential for continuing and expanding beyond the scope of this project, to meet the goal.
